Business idea



- **Financial**: Capacity and willingness to pay dividends




Value creation since start

- On June 30, 1993, Svolder was listed on the O-list of the Stockholm Stock Exchange with a net asset value of 320 MSEK and roughly 1,700 shareholders.
- By August 31, 2023, the net asset value had grown to 5.2 billion MSEK, and the shareholder count had surged to about 60,000.
- Over this thirty-year span, Svolder has also distributed approximately 1.4 billion SEK to its shareholders.

Dividend history

- Svolder strives for long-term, sustainable dividend growth.
- Our dividend policy mandates that dividends received from portfolio companies, minus ongoing management costs, will be returned to shareholders.
- Our historical dividends have increased by an average of 15% per year.



Battle of Svolder

 Svolder was the location of a significant naval battle in the year 1000. During this conflict, Sven Tveskägg and Olof Skötkonung triumphed over the Norwegian King Olav Tryggvason. While the exact location remains a matter of debate, it is widely believed that Svolder was situated near the island of Ven, in the strait between Sweden and Denmark.
